#### INTRODUCTION

- PUBLIC EXPECTATION THAT CORRUPT OFFICIALS NEED TO BE HELD ACCOUNTABLE THROUGH INVESTIGATION AND PROSECUTION
- CORRUPTION HAS BECOME INSTITUTIONAL, STRUCTURAL AND SYSTEMIC
- EXCLUSIVE RELIANCE ON CRIMINAL LAW IS NOT SUFFICIENT TO DEAL WITH SYSTEMIC CORRUPTION
- COMPREHENSIVE MULTI-DISCIPLINARY APPROACHES, WHICH EMPHASISE PREVENTION AND CITIZEN PARTICIPATION, ARE NEEDED.

BUILDING CONSENSUS ON A SUSTAINABLE ANTI-CORRUPTION REFORM AGENDA, WHICH CENTRALISES AN ALL-OF-SOCIETY APPROACH TO FIGHTING CORRUPTION

### NACS VISION

THE VISION OF THE NACS IS A SOUTH AFRICA THAT HAS:

- ETHICAL, TRANSPARENT, AND ACCOUNTABLE STATE,
  BUSINESSS AND CIVIL SOCIETY SECTORS IN WHICH THOSE IN
  POSITIONS OF POWER AND AUTHORITY ACT WITH INTEGRITY
- CITIZENS WHO RESPECT THE RULE OF LAW AND ARE EMPOWERED TO HOLD THOSE IN POWER TO ACCOUNT
- ZERO-TOLERANCE OF CORRUPTION IN ANY SPHERE OF ACTIVITY
- SUBSTANTIALLY REDUCED LEVELS OF CORRUPTION



#### NACS STRATEGIC PILLARS

- PROMOTE AND ENCOURAGE ACTIVE CITIZENRY, WHISTLEBLOWING, INTEGRITY AND TRANSPARENCY IN ALL SPHERES OF SOCIETY
- ADVANCE THE PROFESSIONALISATION OF EMPLOYEES TO OPTIMISE THEIR CONTRIBUTION TO CREATE CORRUPTION-FREE WORKPLACES
- ENHANCE GOVERNANCE, OVERSIGHT AND CONSEQUENCE MANAGEMENT IN ORGANISATIONS
- IMPROVE THE INTEGRITY AND CREDIBILITY OF THE PUBLIC PROCUREMENT SYSTEM
- STRENGTHEN THE RESOURCING, COORDINATION, PERFORMANCE, ACCOUNTABILITY AND INDEPENDENCE OF DEDICATED ANTI-CORRUPTION AGENCIES
- PROTECT VULNERABLE SECTORS THAT ARE MOST PRONE TO CORRUPTION AND UNETHICAL PRACTICES WITH EFFECTIVE RISK MANAGEMENT

### NACAC MANDATE

THE NATIONAL ANTI-CORRUPTION ADVISORY COUNCIL (NACAC) WAS APPOINTED BY THE PRESIDENT FOR A THREE-YEAR TERM TO:

- ADVISE ON THE EFFECTIVE IMPLEMENTATION OF THE NATIONAL ANTI-CORRUPTION STRATEGY (NACS) BY GOVERNMENT, CIVIL SOCIETY AND THE PRIVATE SECTOR.
- ADVISE ON STRENGTHENING SOUTH AFRICA'S ANTI-CORRUPTION ARCHITECTURE
- HOST THE NATIONAL ANTI-CORRUPTION SUMMIT(S), BRINGING TOGETHER GOVERNMENT, CIVIL SOCIETY, THE PRIVATE SECTOR AND ACADEMIA
- ADVISE ON THE IMPLEMENTATION OF THE ZONDO COMMISSION RECOMMENDATIONS FROM A STRATEGIC AND SYSTEMIC PERSPECTIVE
